**MEMORANDUM OF ASSOCIATION OF GLOBAL WISDOM EDUCATIONAL AND CHARITABLE SOCIETY, DASHMESH NAGAR, BARWALA ROAD, DERA BASSI, DISTT. SAS NAGAR, MOHALI (PB).**

**1. Name and address**

(a) The Name of the SOCIETY shall be **GLOBAL WISDOM EDUCATIONAL AND CHARITABLE SOCIETY, DASHMESH NAGAR, BARWALA ROAD, DERA BASSI, DISTT. SAS NAGAR, MOHALI (PB).**

**(b) REGISTERED OFFICE :**

The Registered office of the SOCIETY will be at **DASHMESH NAGAR, BARWALA ROAD, DERA BASSI, DISTT. SAS NAGAR, MOHALI (PB)** or where the SOCIETY decides from time to time.

**2. AREA OF OPERATION:**

The area of operation of the SOCIETY shall be throughout Distt. SAS NAGAR, MOHALI, Punjab /India.

**3. AIMS AND OBJECTS:**

The object for the SOCIETY is established are:

- a. That the main object of the Trust/Society shall be to provide education at all levels, encourage to all classes of people at all levels irrespective of caste, creed & religion and other like objects at various places in the country and abroad and work for Secular tenets in the society.
- b. It is a SOCIETY with a difference in the sense that it has futuristic approach to Education. It aims at producing men and women of character who, besides becoming God - Loving, polite, courteous, considerate, cultured and respectful, learn the significance of self-discipline, humility and service to humanity.
- c. To provide material and support to improve environment and to preserve historical monuments/places/historical artistic work/art etc. directly or indirectly irrespective of any religious belief associated with it/these in any manner whatsoever may be.
- d. To establish and form Self Help Groups and help them to gain their livelihood and to acquire, market, production of such self help groups and to provide necessary know-how and viability & feasibility analysis to Self Help Group's to establish any new project or venture.
- e. To acquire, construct and maintain buildings including land for School, Hospital or any other and alter, extend, improve, repair or modify the same or any existing building and to equip the same with light, water, drainage, furniture, fitting, instruments, apparatus, appliances and all other necessaries for the use of the students, poor and other persons irrespective of the caste, creed, race or religion.
- f. To accept and receive in any manner any cash, cheques, drafts, movable or immovable property either unconditionally or subject to any special Trust created by

any particular donor in furtherance of any one or more of the object of the Trust/Society and to sell, manage, transfer, exchange, mortgage, demise, gift, dispose off or otherwise, deal with any property belonging to the Trust/society.

- g. To establish, provide, grant & distribute Awards, Scholarships and such other incentives to the talented in learning, sports and in fine arts and to conduct literacy programmes among the illiterate villagers and engage students in training and teaching the villagers about hygiene, cleanliness, common diseases & their preventives, childcare and civic conscience.
- h. That the object of the Trust/Society shall be to propagate and encourage for Social, charitable and other welfare works for all classes of people at all levels irrespective of caste, creed & religion and publish books and other like objects at various places in the country and abroad and to increase co-operation, welfare, trust, religious feeling among the people working in all walks of life.
- i. To help and look after the Handicaps, Orphans, widows, Senior Citizens, Sick and other needy/poor people/students by providing them facility of free education, clothes/uniform and books, medicines, hospitalization, food, residence or by arrangement of marriages/ by giving donation on marriages, hostels, homes, hospitals, dispensaries, and other facilities for their betterment and welfare of these people.
- j. To collect funds through contributions, donations, subscriptions grants, gifts, devices, bequests and trusts from any person i.e from its trustees/members and from public, philanthropists, Government and non-Government organizations of India or by conducting charity shows in India or abroad to undertake the activities of Trust/society
- k. To organize health check-up camps for poor and needy people and to perform last rites of unclaimed bodies of human being or that of animals and to work hard to remove social evils like dowry, drug addictions, drinking, gambling, female feticide etc. and to develop a health as well as critical attitude towards development of mental, physical and moral uplift of the people of the country.
- l. To negotiate with and to enter into any manner of arrangements with any Government or Authority whether Central, State, local or otherwise or any public or private body as may seem conclusive to the promotion and accomplishment of the objectives of the Trust/society or any of them, and to apply for, obtain, collect or receive from any such government, authority or body such grants, allowances, concessions, rights or privileges as may seem from time to time, desirable, and to carry out, exercise, comply with and use the same.
- m. To raise loans, borrow money, mortgage trust/society property for the objects of the trust/society on such terms and conditions as they deem necessary to raise the funds.
- n. To help or amalgamate other body or institution to carry out any public object (s) and to do all such other acts and things as are incidental or may be thought conducive to the attainment of the above objectives or any of them.

4. Other Charitable and welfare aims of the SOCIETY:-


- i. The SOCIETY is established to help the general public (irrespective of their Caste, Colour, Sex and Creed) to get educated by opening new avenues & knowledge in the fields of elementary, secondary, technical, moral education through its branches.
- ii. To further and promote the cause and interest of the people belonging to the economically weaker section of the SOCIETY in the field of education so as to make the student eligible and competent for various competitive examinations.
- iii. Inculcate among the student community the spirit of followings of discipline, dedications and duty and devotion for building a strong nation as well as true democracy based on secularism as annunciated by humanism.
- iv. To open various branches, schools, colleges and coaching-centers under the **GLOBAL WISDOM EDUCATIONAL & CHARITABLE SOCIETY** so as to provide better education to the students.
- v. The SOCIETY will organise international welfare and development activities or school under the SOCIETY and to promote the international standard of education and its development. It shall also encourage the research work in the field of education. It will also promote health education in the masses.
- vi. The Society will try to give education to the students through scientific method and audio visual coaching for positive and development in the SOCIETY as a whole.
- vii. To organise conduct and manage well equipped physical education centre and to give training in games sports, athletics, gymnastics etc.
- viii. The institutes run by the SOCIETY are aimed at giving a qualitatively high standard of education, making the students responsive to the social needs of the SOCIETY. Social values are imparted through the house system, co-curricular activities and collective games, efforts are made to import vocational training and inculcate a sense of dignity of labour .
- ix. The SOCIETY will have no concern with any of the political parties nor have any political aim of any type.
- x. The SOCIETY will approach the Central/State Govts. to seek financial assistance as well as the required infrastructure/permissions to achieve the aims and objects of the SOCIETY.
- xi. To engage teachers, instructor and experts of good moral character and capable to impart efficiently and economically up-to-date instructions to students in education in modern sciences, industrial vocations, research work, intellectual and other usual pursuits.
- xii. To develop a healthy as well as critical attitude towards the development of mental, physical and moral uplift of the students and those connected with the institution so as to make them good citizens.

- xxiv. To help the common people to get education by opening new avenues and visits in the field of pre-primary, Elementary, Secondary, Formal and Non-Formal, Moral and Spiritual, Technical and Scientific Education.
- xxv. To organise hold and conduct meetings, groups discussions, Lectures, Speeches, workshops, seminars, conferences, researches, projects, clinics and study programmes for the purpose of exchange and dissemination of information and ideas.
- xxvi. To include among the student community the spirit and feeling of discipline, dedication and Devotion for building a strong nationas well as true secularism and basic principles of Humanity.
- xxvii. To open school, Branches and coaching centers of academics, so as to provide chances or inexpensive and better facilities as education to the student community.
- xxviii. To establish, maintain and develop libraries, reading rooms and publishing institutions for publishing or publications of books, journals, magazines, periodicals, booklets or education and training.
- xxix. To provide scholarship, prizes, medals or other awards connected with the Examination held by the "society".
- xxx. To seek affiliation/recognition from various state Government Education Boards and Universities so as to achieve its aims and objects.
- xxxi. To approach the State/Central Govt. to seek and get financial assistance other Financial facilities as well as the required infrastructure to achieve the aims and objects of the SOCIETY as provided therein the bye-laws of SOCIETY.
- xxxii. To ask and approach of the banking institutions for the advancement of Loans for construction of Building, stadium, purchasing and hiring of furniture, Transport(Conveyance) educational, equipment and other machinery.
- xxxiii. To accept and receive subscriptions, fees, gifts, donations and grants in cash or kind, from Government or any other person, provided that the conditions if any, attached there to and not inconsistent with the aims and objects of the SOCIETY.
- xxxiv. To accept as fist, purchase take on lease, hire, construct and maintain or otherwise acquire any movable or immovable property, rights and privileges on such terms and conditions as may not be inconsistent with the objects of the SOCIETY.
- xxxv. To appoint such-sub-committee (s) as well as advisory Board (s) so as to fulfill the obligation of the bye-laws as provided therein.
- xxxvi. To seek legal remedies by civil suits, appeals, writ petitions, complaints etc. in public interest before various courts, Forums and Tribunals up to highest level and up to the High Court and the Supreme Court.
- xxxvii. The SOCIETY shall be a non profit making organizations and its income shall be utilized for the promotion of its aims and objects.






**RULES, REGULATIONS AND BYE-LAWS OF GLOBAL WISDOM EDUCATIONAL & CHARITABLE SOCIETY, DERA BASSI.**

**1. DEFINATION:-**

"The word and expression contained in these Rules and Regulations shall have the same meaning as in the Act or Statutory modifications thereof. However the following words and expressions shall have the meaning expressed against each, unless they are repugnant to the subject or context".

a) **ACT :-** Shall mean the Punjab Firms and Societies Act, 1860, Registration.

b) **GWECS :-** Shall mean GLOBAL WISDOM Educational and Charitable SOCIETY.

c) **HEAD OFFICE:-** Shall mean Central and administrative Office of the SOCIETY from where the day to day administration of the SOCIETY shall be carried on -in accordance with the provision of the bye- laws.

d) **RULES AND REGUALTIONS:-** Shall mean the rules and regulation (Bye- Laws) of the SOCIETY. These shall formed adopted amended or alter therein by the General Body of the SOCIETY i.e. **GWECS**.

e) **MEMORANDUM :-** Shall mean the memorandum of the association under section 2 of Societies Registration Act, 1860.

f) **AMENDMENT :-** Shall mean to correct reform or alter the provision(s) of rules and regulation in order to facilitate the SOCIETY to achieve its aims and objects. This power solely lies with the General Body of the SOCIETY.


g) **EXECUTIVE COMMITTEE:-** Shall mean the executive committee of **GLOBAL WISDOM Educational and Charitable SOCIETY, DERA BASSI**. This committee shall be elected by the members of General Body in accordance with the provision(s) contained in the bye-laws of the SOCIETY.


h) **SOCIETY PROPERTY :-** Shall mean all movable and immovable property belonging to in the possession of the SOCIETY and all other rights and interests in, or arising out of such property and includes land, building and its appurtenance, playgrounds, furniture, books, equipment, cash reserve funds investments and bank balances.

i) **SCHOOL/INSTITUTE :-** Shall mean Pre-Primary, Primary, Middle, Higher Secondary School, Diploma/Degree Colleges/Management Institutes Etc. Managed and controlled by the SOCIETY.

j) **FINANCIAL YEAR :-** Shall mean the accounting year of **GWECS**, commencing on 1<sup>st</sup> April to 31<sup>st</sup> March each year.

k) **MEMBER** :- Shall mean the member holding primary membership of the **GWECS**.

l) **JURISDICTION**:- Shall mean the constitutionally defined and demarcated boundaries of the India i.e. the Jurisdiction of the operation and working of the **SOCIETY**.

**2. ELIGIBILITY FOR MEMBERSHIP:-**

- a) He/She should be a bonafide Citizen of India.
- b) He/She should be an adult as per the law.
- c) He/She should possess a sound mind.
- d) He/She should have interest in Education as well as Social/Welfare activities.
- e) He/She should have full faith in the constitutions of **GWECS**.
- f) He/She should not be an insolvent.
- g) He/She should be economical viable.

**3. MEMBERSHIP FEE SHALL BE AS UNDER :-**

- a) Entrance fee : Rs. 5,000.00
- b) Annual Subscription : Rs. 1,000.00
- c) Life Membership fee in Lump sum : Rs. 20,000.00

**4. CESSATION/REMOVAL OF MEMBERSHIP:-**

- a) In the event of non-payment of annual subscription and other funds.
- b) In the event of his tendering resignation.
- c) In the event of Death of a member.
- d) In the event of absent more than five meetings of the executive committee.
- e) In the event any member fails to perform of his/her duties or doing any act which is against the interest of the **SOCIETY** or due to any other reason which governing body think fit, meeting of general body may be called and its decision shall be conclusive and binding. Such a decision shall not be challenged before any authority or Court of Law.
- f) In the event of Un-dissolution of the **SOCIETY**.

**5. CHARACTER OF THE SOCIETY:-**This **SOCIETY** is purely a Educational and Social Welfare Body. It is purely a Non- Political body.

**6. GENERAL BODY:**

- a) General body shall consist of not less than 8 members and shall not exceed 15 members.
- b) It shall be the supreme supervisory organ of **SOCIETY** to control sheet, direct and guide the day to day working of the **SOCIETY** through its own duly elected executive committees.

i) It shall purchase, hire, acquire any movable or immovable property on such terms and conditions which is consider necessary for the attainment of the aims and objects of the SOCIETY. But it will be subject to the approval in General body meeting.

j) It shall recommend of these regulations.

k) It shall execute and sign all documents and to enter into contracts or engagements on the behalf of the SOCIETY and to secure the fulfillment thereof.

l) It shall set aside out of the funds of the **GWECS**, such sums as it thinks fit and proper as a reserve for purchase of land buildings and other properties for the SOCIETY.

m) It shall form and supervise the functioning of institutions belonging to the **GWECS**.

n) It shall appoint any committee or sub-committee for performing any task of the SOCIETY subject to its control and supervision.

o) It shall do all other acts, deeds and things for the fulfillment furtherance and promotion of the interest of the SOCIETY and its aim and objects, subjects to these regulations.

#### 9. OFFICE BEARERS AND THEIR DUTIES AND FUNCTIONS:

There shall be a team of Office bearers consisting of Chairman, Vice Chairman, General Secretary, Treasurer along with two Executive members. The Office bearers shall be collectively responsible to the General body.

a) **CHAIRMAN** : There shall be a Chairman of the SOCIETY. The Chairman shall be elected by the General Body. He shall hold his Chairman ship for a term of five years. He shall be eligible for re-election. He shall be the Head of the SOCIETY. He shall preside over the meeting of General Body and Executive Committee. He shall do all other duties so as to fulfill the obligations as contained in the bye-laws.

b) **VICE CHAIRMAN** : There shall be a Vice Chairman duly elected by the General Body. The Vice Chairman shall perform all the duties of the Chairman in his absence. He shall also do other duties as assigned by the Chairman.

c) **CASHIER** : There shall be a cashier duly elected by the General body. The Cashier shall perform such functions as the executive committee may determine from time to time. Cashier shall be responsible to maintain the cash book and ledgers of the SOCIETY. He shall also check and sign all the vouchers and cash memos and get these duly passed by the Chairman. He shall also prepare the annual budget as per guide lines given by the Chairman. He shall present the budget in the meeting of General Body for getting its approvals.

d) **GENERAL SECRETARY** :- The General Secretary shall write down (Record) the proceedings of the General body and Executive committee. He shall maintain the complete and up to date record of SOCIETY. He will summon and attend the meeting of the SOCIETY. He shall do other duties as may be assigned to him by Executive committee or its Chairman.

e) **PRINCIPAL OR HEAD OF THE INSTITUTION:** There shall be a Principal Administrative of the Educational Institute as managed by the SOCIETY. Principal shall be appointed by the Chairman with the consent of selection committee. Principal shall not be member of General body or Executive Committee. Principal shall look after Educational and Administrative affairs of the institution. He shall perform such function as the committee may from time to time determine.

10. **ELECTIONS :-** The Executive committee (Body) shall be elected by two third present members of the General body. All the present members shall have the right to sign of vote. The Executive committee so elected shall continue for a period of five years from its election. The candidate (s) receiving the largest number of votes shall be declared duly elected.

11. **QUORUM :-** Five members shall constitute quorum at a executive committee. All the decisions shall be taken by majority of votes. Quorum for General Body's meeting shall be fifty percent of the total members.

12. **LIABILITIES AND ASSETS:-** The General body of the SOCIETY through the executive committee(not in individual/personal capacity of member/office bearer)shall bear all the liabilities of the SOCIETY. It shall also be responsible to maintain and preserve its assets in a lawful manner.

13. **ACCOUNTS OF THE SOCIETY :-** The SOCIETY may open one or more Bank Account(s) Executive Committee may authorise its officials to operate the same in the manner and to the extent that may be determined by it. All subscriptions, Donations, Grants, and other money of the SOCIETY shall be deposited in the Bank Accounts of the SOCIETY.



14. **SOURCE OF INCOME:-**

- a) Fees and funds collected from the students.
- b) Donations, grants, gifts from General Public and well wishers, Firms and Factories and other commercial establishments etc.
- c) Its income shall not be distributed among the members but shall be applied wholly for the furtherance of the objects of the SOCIETY.

15. **POWERS TO SIGN LEGAL DOCUMENTS:-**

The Chairman and Vice Chairman shall have the power to sign all legal documents on behalf of the **GWECS** in accordance with the provisions of bye-laws of the SOCIETY.

**16. DISSOLUTION OF THE SOCIETY:-**

1. Any number not less than 3/4<sup>th</sup> of the members of the Society shall determine that the Society be dissolved whether forthwith or at any future time then agreed upon
2. If on the dissolution of the Society there shall remain after the satisfaction of its debts and liabilities any property whatsoever not impressed with any Societies, agreed between the Society and the Donor or Donors the same shall not be paid or distributed among the members of the Society or any of them but shall be given to some other society or institution working for the same or similar objects as those of the Society to be determined by at least 3/4<sup>th</sup> of the members of the General Body at the meeting convened for the purpose or in default thereof by the Principal Court for original Civil Jurisdiction at Dera Bassi, in which the office of the Society is situated.

**17. INTERNAL AND EXTERNAL CONFLICTS OF THE SOCIETY:-** The Chairman of the SOCIETY is empowered to deal with all the law suits (Civil & Criminal) against or on behalf of the SOCIETY. In case any internal conflict arises then the Chairman and Vice- Chairman are jointly entitled to seek the legal remedy. In case of any serious dispute which cannot be settled by the Executive committee which is likely to create danger to any of its institutions, such dispute must be decided by the General body and its decision shall be conclusive and binding. Such a decision shall not be challenged before any authority or Court of Law.

**18. MEETINGS OF THE EXECUTIVE COMMITTEE:-** The Executive Committee shall definitely meet once in a month. In spite of this fact an emergency meeting can be called by its Chairman at 24 hours notice in black and white, if circumstances demand so. The information of such meeting must be conveyed by the General Secretary to the members in person.

**19. SPECIAL MEETING OF THE GENERAL BODY:-** Generally the permanent meetings of the General body will be held in the month of September and March of the financial year. There is a scope to call a special emergent meeting of the General body. Such a meeting will be held at SOCIETY's Head Office. Such a meeting shall be called by the Chairman through General Secretary and a clear notice of 7 days is must for holding such meeting. The necessity of such a meeting depends on the circumstances according to the discretion of the Chairman.

**20. REQUISITE MEETING OF THE GENERAL BODY:-** In case of any emergency where the Chairman or any other office bearer fails to discharge his lawful duties, 1/3 members of the total strength of the General Body can ask the Chairman to call Requisitioned meeting. A clear seven day notice is must to call such a meeting. Even in the event of need, Chairman will fully averts to call such a requisitioned meeting. The same notice can be served to Vice Chairman to call such a meeting. The V.P. is bound to call such a meeting through General Secretary. The concerned members of the General body must be served on written notice along with a detailed agenda of the meeting. Vote of no-confidence can be moved and passed against the Chairman and other office bearer of the Executive committee with the special permission of the chair.
